## 1. Opening and welcome

 Councillor Kaotsane Oageng opened the meeting with a short prayer and the Speaker welcomed all attendants.

# 2. Formal Constitution

## 3. Disclosure of Interests

■ The Speaker read Notice on Disclosures of Interests in terms of Schedule 5(1)(a) of the Local Government: Municipal Structures Act, 117 of 1998 and no disclosures were made.

## Presentations by the Office of the Auditor-General

- Mr Charles Baloyi , Auditor-General's representative presented to council on the following:
  - i. That the Joe Morolong Local Municipality is working towards a positive direction and that its detailed Audit Action Plan should be implemented accordingly because it should assist in improving the Audit Outcomes for the 2015/16 Financial Year
  - ii. That the Internal Committee was audited on performance and did very good in that regard and that its performance should have a positive impact on the municipal performance
  - iii. The recurrence of issues was less than previous years except that the Technical Services has qualified in the area of non-provision of evidence whilst the Community Services has improved.
  - iv. It was noted that the annual budget was far less than the actual expenditure incurred. It was recommended that such activity should be disclosed in the financial statements and that evidence should accompany all disclosures.
  - v. It was noted that Grants were wrongly classified as revenue.

## **Recommendations:**

- That disclosure should be made when the expenditure exceeds the approved budget
- That evidence should be provided with each disclosure
- That the targets should be clear and reasons for not achieving stated to validate the information provided.
- That the incorrect classification of Grants should be corrected
- That the compliance register should be followed and the Transaction Register investigated, reports presented and actions taken or monies recovered
- That the Mayor should attend the quarterly audit forums.

## Commitment by the Mayor.

- The Mayor committed that council should play an effective oversight role and ensure the implementation of the Audit Action Plan.
- The Accounting Officer was charged with responsibility of ensuring that there is no regress in the Audit Outcomes and that any officials impeding progress should be reprimanded and charged.
